- **Final Registration deadline is April 3, 2017 (form & fee) - As space allows.**
- **Space is limited. Spaces are not automatically held. All booths must register, including AZ Network Affiliated Ministries.**
- **Vendor set up is only permitted during the established set up time of 2:00pm and 5:00 p.m. Tuesday, April 18th**
- **Booth breakdown must be completed by 6:00pm Thursday, April 20th.**
- **All goods and services offered must be appropriate for Assemblies of God Ministers and their families. Vendors and booth attendants must be appropriate to a family-friendly, Christian environment.**
- **Vendors will need to notify winners and award their prize themselves.**
- **Each vendor will be provided with a 6ft table for their booth. Vendors must provide their own tablecloth**
- **Vendors must provide their own refreshments, or register for the event themselves to be able to participate in District-provided food and beverage.**
- **The name of each booth attendant must be registered with the Arizona Network Conference, and all booth attendants must wear their Exhibitor Name Tags throughout the event. Please provide a list of attendants at the time of registration as each attendant will need a name tag.**
- **We require one attendant be present during open hours. Those hours are on April 19 and 20, 8am-12pm, 1pm-9pm.**
- **We will do our best to accommodate requests, but vendor booth location and/or access to electricity cannot be guaranteed.**
